1. Introduction

This information relates to the processing of personal data in connection with the Safety Management System.

2. Responsible for content

4. Processing of personal data, purpose of processing

Your data will be processed exclusively for the following purposes:

• Contact and feedback with the detector of safety incidents. This is specified by EU Regulation 139/2014 under [8]

5. Legal basis for the processing of personal data

- Protection of the legitimate interests of the person responsible (Article 6(1)[f] DS- 6V0)
- In order to fulfil a legal obligation (Article 6 (1) (c) DS-GVO) applies to the processing of personal data by those involved in safety violations EU Regulations 139/2014 and 376/2014 as well as the implementing provisions of EASA.

6. Recipient

• Internal recipients: Employees of the relevant specialized department AVVS Safety Management

7. Transfer to third countries

A transfer to a third country outside the European Union is not intended.



8. Duration of storage

The personal data reported through the online form when reporting a safety incident will be deleted after one year.

9. Data protection requests: Rights of the concerned parties to information, rectification, erasure, restriction of processing, objection, portability and withdrawal of consent

Data subjects have rights to information on the personal data concerned, rectification, erasure, restriction of processing, objection to processing and portability of the data. In addition, data subjects have the right to withdraw a declaration of consent at any time.

Data protection enquiries on Safety Management requests: To exercise rights related to requests for Safety Management, the party submitting the request can initiate contact, preferably by email at the following address: safety@munich-airport.de.

Rectification of data: In particular in case of changes or errors in the indicated data of the party submitting the request, the data subject can have the data rectified. Contact in such cases can be made as described by email at safety@munich-airport.de.

10. Right to submit complaints to the supervisory authority

Without prejudice to any other administrative or judicial remedy, you have the right to lodge a complaint with a supervisory authority, in particular in the Member State of your habitual residence, place of work or place of the alleged infringement if you consider that the processing of personal data relating to you violates the law. The supervisory authority in the state of Bavaria responsible for the non-public area of the airport is: The Bavarian State Office for Data Protection Supervision, Ansbach.

11. Obligation to provide personal data

The provision of data that is not marked as optional is required for registration and the allocation of access rights.



12. Automated decision making (including profiling) and the consequences

No automated decision making is carried out.
